#### **Six Held, Firearm, Ammunition and Cannabis Seized in Weekend Exercises**

Six suspects were arrested and a firearm and quantities of ammunition and cannabis seized during ongoing State of Emergency operations in the Central, Southern and South Western Divisions.

In the Central Division, Task Force officers conducted an exercise between 10 am and 2 pm, on Saturday 4<sup>th</sup> October, 2025, during which they proceeded to the Carapichaima district, where they intercepted a motor vehicle with two male occupants.

A search of the vehicle resulted in the discovery of one revolver loaded with five rounds of ammunition and one spent round.

The men, a 29-year-old of Carapichaima and a 33-year-old of Freeport, were arrested in connection with the find.

The operation was coordinated by Supt. Glodon, ASP Harrylal and supervised by Cpl Samaroo and Cpl (Ag.) Phillip.

Meanwhile, in the Southern Division, Task Force officers conducted an exercise between 6:30 am and 7 pm, yesterday, during which they arrested a 33-year-old fisherman and a 24-year-old welder, both of Moruga, for the possession of quantities of cannabis.

The exercise was coordinated by Snr. Supt Simon, Supt. Jaikaran, ASP Ramsaran, ASP Ramlogan and Insp. Wilkinson.

And, two suspects were arrested in connection with a report of Wounding with Intent to do Grievous Bodily Harm, which occurred

in the Siparia district on September 18<sup>th</sup>, 2025, against a male victim.

Following diligent investigations, detectives of the Siparia Criminal Investigations Department, held a 37-year-old and a 29-year-old both of Siparia in connection with the matter.

The suspects face charges including Wounding with Intent to do Grievous Bodily Harm, Possession of Firearm, Possession of Ammunition, Possession of Firearm to Endanger Life and Possession of Ammunition to Endanger Life.

They are expected to appear before a Master of the High Court this week.
