### MEDIA RELEASE

#### **Over \$230,000 in Outstanding Warrants Cleared During Multi-Divisional Police Operations**

In a concerted effort to enforce outstanding court orders and ensure public accountability, officers of the South Western and Southern Divisions executed a total of 92 warrants and arrested 56 persons during two large-scale warrant operations conducted between September 11<sup>th</sup> and 12<sup>th</sup>, 2025. These operations resulted in the execution of several high-value Affiliation and Commitment Warrants, amounting to more than \$230,000 TTD in outstanding court-ordered payments.

##### South Western Division Operation

Area West – 11<sup>th</sup> September 2025 (2:00 AM – 2:00 PM)

This operation was coordinated by Snr Supt Thompson, ASP Lewis, ASP Corrie, Insp Harripersad, and Insp Sirju, and supervised by PCs Boodoo and Johnitty of the Guapo Police Station, with support from Court and Process officers.

- 59 Warrants Executed
  - 28 Time Allowed Commitment (TAC)
  - 24 Affiliation (AFF)
  - 7 First Instance (FI)
- 34 Persons Arrested

Among the individuals arrested were several repeat offenders with multiple warrants. These included:

- A 44-year-old labourer with 6 TAC warrants
- A 50-year-old rigger with 2 AFF warrants
- Multiple other persons with 2–3 outstanding warrants each

##### Southern Division Operation

Division-Wide :- 11<sup>th</sup> Sept (10:00 AM) to 12<sup>th</sup> Sept (6:00 AM)

This initiative, aligned with the ongoing State of Emergency regulations, was coordinated by Snr Supt Simon, Supt Jaikaran, ASP Ramlogan, ASP Ramsaran, and A/Insp Ramsaran, and directly supervised by Cpl Madhoo and PC Mahase.

- 33 Warrants Executed
- 22 Persons Arrested
- Incident-Free Operation

This operation notably focused on Affiliation Warrants, court orders related to outstanding child maintenance payments and related family court matters. Some highlights include:

- A 40-year-old, labourer of Mandingo Road, Princes Town – 2 warrants totaling \$74,000
- A 44-year-old, Labourer, of Warden Road Gasparillo – 3 warrants totaling \$63,750
- A 36-year-old labourer of St. Croix Road, Princes Town– 3 warrants totaling \$9,272.50
- A 54-year-old labourer of Forth Street Corinth, Ste. Madeleine – 2 warrants totaling \$10,975
- Other individuals with outstanding sums ranging from \$1,200 to \$8,400

Total Warrant Value Cleared: \$232,223.50

- South Western Division (Est.): Approx. \$60,000 in AFF and TAC warrants
- Southern Division: \$172,223.50 in AFF and Commitment Warrants

These operations are part of a continued commitment by the Trinidad and Tobago Police Service (TTPS) to uphold the law, enforce court orders, and support justice in all forms including financial obligations tied to family and civil court matters.

TTPS Reminds the Public: Ignoring court-issued warrants, especially those related to family responsibilities can lead to arrest and detention. Citizens are urged to proactively address any outstanding legal matters. The TTPS continues to work diligently to maintain law and order while supporting the judicial process through effective enforcement.
